# Field Safety Notice concerning 4008 Paediatric Bloodlines:

#### AV-SET FMC PAED S (6014611)

Dear Customer,

During the continuous monitoring of our bloodlines on the market, we have become aware of single cases of leakage between the arterial bubble catcher and the connecting tubes of the bloodline. Results of our investigations have indicated an insufficient gluing between the arterial bubble catcher and the connecting tubes of the bloodline (see picture 1).

In most reported cases the leakage was detected during priming, in the preparation phase. However, there might be a potential risk for the patient if defect bloodlines are used. To our knowledge up to now no patient has been affected.

Fresenius Medical care is committed to offering quality products and superior customer service. Therefore we have decided to inform all our customers and to replace the involved lot numbers distributed in the market as soon as new batches are available.

In the meantime we strongly recommend that you examine the bloodlines carefully before use and do not use any lines which are defective.

Defective bloodlines can be identified by means of visual inspection as follows:

Take the bloodline out of the blister and check the prober connection of the arterial bubble catcher and the attached tubes (see picture 1).

- a. If the highlighted area is transparent, the bloodline can be used safely and effectively (see picture 2).
- b. If the highlighted area is dull, the bloodline is defective and must not be used (see picture 3).

We are working intensively to solve the problem in order to ensure highest quality standards for our customers. You will be contacted by your local Fresenius Medical Care representative to organize the replacement of the affected bloodlines.

#### Please make sure that all users of the above mentioned bloodlines in your organization and other concerned persons are informed about this Field Safety Notice.





Picture 1: Arterial bubble catcher




Picture 2: Safe connection (transparent)
