Attention: BALTACCI users

This FSN is issued based on an incident which has been reported in Czech Republic. This incident mentions the rupture of a BALTACCI 1,5F catheter during ONYX ® injection with a 1 cc syringe despite it was stated in all the versions of the IFU that the injection should not be done with a syringe smaller than 2.5cc.

There were no clinical consequences for the patient.

Although the material of the micro catheter BALTACCI is compatible to DMSO, the tubes are not braided and hence the catheter pressure resistance is limited.

The liquid embolic devices, containing DMSO, are provided with 1 cc. syringes which can lead to high pressure during injection which could induce catheter rupture.

To avoid any confusion, we have deleted the mention "DMSO compatible" in the Instruction for Use and replaced it by:

CAUTION: the BALTACCI catheters are not compatible with embolization agents containing DMSO

PRECAUTIONS: never use the BALTACCI catheters with embolization agents containing DMSO
