### Description of the problem

GBUK has voluntarily initiated the recall of the specific product code and batch number listed above.

There have been complaints relating to the outside wall of the Naso-gastric feeding tube splitting at a point of contact with the ENFIT connector.

Should the event described above occur, feed may leak from the tube or the tube may become separated from the ENfit connector.

Although the patient risk is considered low, this may result in the patient not receiving feed and adequate nutrition until the device is replaced.

### Action to be taken by the user

GBUK records show that you have received the above product code and batch combination.

1. Immediately remove any affected product that is in situ with any patient.
2. Immediately quarantine any stock of NCI06.050ISOSAF-ROW batch 18001594 you have.
3. Please complete page 2 of this field safety notice and return to GBUK Enteral, who shall then arrange collection of the stock you have quarantined of this batch number.
