
According to our records, you have received products from one of the LOT numbers listed below.

We urge you not to use any of these suction cannula and to return the suction cannula still in your inventory.

#### Defects in the product, the cause of the security message

Si Us Instruments GmbH is recalling the product listed above after a customer reported that the suction cannula was found to be contaminated (cleaning residue) in the primary/sterile packaging (peel bag) during an obligatory visual inspection (incoming goods inspection) and the product was reported/complained to us accordingly. As an immediate measure / action, the affected suction cannulas were immediately blocked by the customer for further use.

#### **Emanating risk from the product**

All affected customers were immediately contacted by telephone in advance of this urgent safety notice and instructed to block the potentially affected products.

Since the suction cannulae in question were blocked for further use immediately after the above-mentioned defects were discovered and were not put to use, none of the following consequences could have occurred, either directly or indirectly:

- (a) the death of a patient, user or other person,
- (b) the temporary or permanent serious deterioration of the state of health of a patient, user or other person,
- (c) a serious risk to public health.

#### Instructions for action / Necessary measures

The product must be discarded. Discarded products must be returned to the manufacturer according to the instructions for use.

Upon receipt of the returned affected products, you will receive a credit note.

Please pass on this safety information to all persons within your company to all persons within your company or in other companies to whom potentially affected products have been passed on and who need to be informed about the Urgent Safety Information. need to be informed.

Please keep this information at least until the measure has been completed.
