Detail on affected devices:

Uritest 13G Urine Reagent Strips All batches

Description of the problem:

From the customers' feedback & the following inspection, we confirm that there's something problem with Uritest 13G urine reagent strips, which can be listed as follows:

- 1. Having a colour chart on the label may lead the users to misuse the product for visual use. Actually the lot No.20090227 and the earlier lot No. product label are only for reference, it can't be used to judge & confirm the testing result. Although the intended use with the product lot No. after lot No.20090227 notified to be visual use & analyzer mode use, however, from some users' feedback & the internal evaluation, we confirm that there's considerable risk to cause the false positive result according to the colour chart of microalbumin when it is for the visual use.
- 2. The sensitivity of Uritest 13G's microalbumin is 50-100mg/L, the testing results dividing into two levels, it is "negative" & "≥100mg/L", while the quantities of microalbumin testing as ≥ 50mg/L all reported as "≥100mg/L". The microalbumin cut-off point of Uritest 13G is 50mg/L, while the normal clinical cut-off point for microalbumin is 20mg/L. That means it is not so much clinical significance for the earlier screen of diabetic nephropathy etc.
- 3. There is the feedback from the users to state that it is not enough accuracy for the creatinine testing in this product. The investigation confirm that the creatinine is affected by the humidity to a great degree, if the bottle has been opened, but not be sealed back immediately, the pad mixing with the air for a long time may lead to the testing result of creatinine not correct.
- 4. The design requirement for the dipping length of this product should be longer than 100mm, exceeding the height of the normal urine sample pots in some areas' market. In this case, it can't make sure that the pad has been dipped in the urine totally.

- 3. Because the stability of creatinine is affected by the humidity easily, please make sure that after taking out the urine strip for use every time, fasten down the base cover immediately, otherwise the testing result may be incorrect because of the long exposing time.
- 4. Our company can't do the improvement about the length & sequence of Uritest 13G, in consideration of the possibility of insufficient dipping, we remind you to make sure all the pads have been dipped totally while do the using.
- If you have purchased the Uritest 13G urine reagent strips for visual use, or as the function of microalbumin can't meet your satisfaction, you could return back the goods to us via the local distributor or contact with us directly.
