Questions and Answers

1. What impact does the presence of residue on the underside of some microtiter wells have on MESOMARK results?

We have confirmed that MESOMARK kit Lots 57K04409 and 57K04510, may generate inaccurate absorbance values due to the presence of a residue on the underside of some microtiter wells that can be detected visually. The residue on the underside of some microtiter wells may or may not cause an elevated percent Coefficient of Variation (%CV) within replicates. The inaccurate absorbance values and/or elevated %CV may affect the calibration curve, controls and/or test results. MESOMARK kit Lot 57K04409 is expired but expected to be similar in performance to 57K04510 due to observed residue.

The Fujirebio Diagnostics, Inc. (FDI) MESOMARK is an Enzyme-Linked Immunosorbent Assay (ELISA) for the quantitative measurement of Soluble Mesothelin Related Peptides (SMRP) in human serum.

3. Is there an alternative method for performing MESOMARK testing?


