

URGENT: FIELD SAFETY NOTICE

December 15, 2014

RE: PF4 Enhanced, PF4 IgG or PF4 Concentrated Wash

Dear Laboratory Manager:

Our records show that you received the above product of Immucor GTI Diagnostics, Inc. Specific kit and reagent lot numbers are provided on page 2 of this communication.

We have determined that the PF4 Concentrated Wash (10X) lots indicated in this letter were manufactured at a slightly more dilute concentration. As a result, this may lead to slightly increased Optical Density (OD) values with results generated using these buffer lots.

The increased OD values are not expected to cause invalid results. Samples demonstrating a higher background reactivity may demonstrate false positive result (borderline reactivity) at or near the cutoff for the assay, but otherwise with no specific anti-PF4:polyanion reactivity.

To date, Immucor has not received any complaints that can be correlated to the OD increase and resulting in any false positive results.

Previous results generated using this lot of product (PF4 Concentrated Wash) may be considered valid provided that:

- 1. testing was performed according to the package insert instructions,
- 2. quality control testing gave acceptable results,
- 3. consideration was given to the LIMITATIONS section of the package insert, and
- 4. borderline positive results were reviewed in relation to additional clinical and testing information that may be available.

Instructions for correction of the affected product:

- 1. Stop using the affected PF4 Concentrated Wash.
- 2. <u>Do not</u> destroy the other components of the Kits.

Concurrent to this letter we are sending you replacement PF4 Concentrated Wash based on the total number of kits you have previously ordered. If there is an urgent need for additional wash buffer, please contact Technical Support at 262.754.1000 or waukeshatechsupport@immucor.com

- 3. Log the number of bottles and Lot number of the PF4 Concentrated Wash on the Customer Response Form.
- 4. Determine additional number of bottles of PF4 Concentrated Wash you require besides those already provided as part of this action. Log this number on the Customer Response Form.
- 5. Destroy the affected PF4 Concentrated Wash.

- 7. All orders shipped after December 9, 2014, will contain non-affected PF4 Concentrated Wash.
