Explanation Due to a filling process mistake the compartment of reagent R2 of the twincontainer was filled with reagent R1. Therefore, both compartments of the twincontainer contain reagent R1.

Impact on patient results The essential chemical reaction process will not take place when using only reagent R1 for the measurement. The control samples will show false high results; approx. 80%. Thus, there is no patient risk if a control recovery is performed according to good laboratory practice.

Measures For explained reason, the above mentioned kit lot of UIBC FS is withdrawn from the market. DiaSys offers replacement for the affected kits.

The above mentioned kit lot must not be used any more. Existing stock must be disposed of.

Please discuss with the head of laboratory if patient values determined with the above mentioned lot should be repeated by using a different lot.


