Dear Valued Tosoh Customer,

This letter contains important information regarding the G8 Elution Buffer HSi No.2 (S) (P/N.: 0021801), which is used in conjunction with the Tosoh Automated Glycohemoglobin Analyzer HLC-723G8 provided by Tosoh Europe to your facility. As part of this action, Tosoh is initiating a voluntary recall for lot R8-203H of the G8 Elution Buffer HSi No.2 (S).

Background

Auto-packing machines are used to pack Elution Buffer pouches into product boxes. An internal investigation revealed that during the assembly of the G8 Elution Buffer HSi No.2 (S) (P/N.: 0021801), a residual amount of G11 Elution Buffer No.1 (S) pouches were left in the auto-packing machine. Consequently, these G11 Elution Buffer No.1 (S) pouches were packed into G8 Elution Buffer HSi No.2 (S) boxes.

Risk to health

In the event that G11 Elution Buffer No.1 (S) is used instead of G8 Elution Buffer HSi No.2 (S) on Tosoh Automated Glycohemoglobin Analyzer HLC-723G8, the obtained result will be "0.00 HbA1c".

As the obtained result of "0.00 HbA1c%" clearly indicates an inaccurate measurement, the risk of incorrect patient treatment based on these results is minimal. Therefore, we concluded that the associated risk linked to this event is very low.

Corrective Action

The manufacturing team has taken measures to prevent this from occurring in the future, by implementing additional steps in the manufacturing and packaging processes.

- 1) Ensure that all the contents of this Field Safety Notice are read and understood by those within your organization who need to be aware.
- 2) If you have further distributed the impacted product, please forward this notice and all the related documentation to those users(s).

Tosoh will provide you with a new G8 Elution Buffer HSi No.2 free of charge.
