Description of the problem: As a result of reports from the market we have identified a possible variation in the size of the 22F mask taper of Economy, Anaesthetic Face Masks, where some masks may be larger than standard limits. This may create a loose or insecure connection with the mating device, and in some circumstances this could result in possible disconnection from the mask taper.

The resuscitator catalogue number 7152012 includes Economy, Anaesthetic Face Mask, size 4. In an emergency situation when using resuscitator there may be no possibility to have a spare mask and this could result in inability to perform cardio pulmonary resuscitation effectively.







Action to be taken by the user:

Immediately quarantine all affected lot numbers listed above and do not use these devices.
