Field Safety Notice
Supplement to the labelling and instructions for use
Concerning the refraction units
Ecocentric
HS-810
Sinus

Addressee:

This Field Safety Notice is addressed to all HS Doms distributors and their customers.

Identification of the affected medical devices:

This corrective action affects the Ecocentric, Sinus and HS-810 refraction units, which are equipped with a 2-device table. Affected devices can be identified using the serial number on the nameplate. The nameplate is located on the back of the refraction unit, where the power supply cable is connected to the device. A list of affected serial numbers is attached.

Description of the problem including the determined cause:

At testing of the refraction unit, a non-compliance with the EN 60601-1 standard was determined. If the table is swivelled back in its extended position (position 2) without being pushed back to position 1 first, the refraction unit may tip over if you lean on the table in that state. If the refraction unit tips over, this can lead to serious injuries of the patient or user. The user is not informed sufficiently about this risk.

Which measures are to be taken by the addressee?

If you have used table instrument 2 and want to bring the table to its rest position, always first slide the table back to position 1 and only then swing it back into the rest position. Do not lean on or sit on the table.

With this letter you will receive a "No Sitting" sticker and a supplement to the instructions for use. Stick the sticker on the instruments table in a clearly visible place.
