Dear Valued Customer,

This letter advises you that BVI is voluntarily recalling one lot of Cat# 373807, of the Conventional Crescent Knife 2.5mm, 55 degrees bevel-up.

The Conventional Crescent Knife is intended to make ocular incisions and indicated for cataract surgery. This knife is a bevel-up knife (meaning the knife's cutting edge is on the top of a knife when looking down on it) and will create an incision that arcs downward upon entering the eye. In contrast, a bevel down knife, with the cutting edges on the bottom of the blade will make the incision arc upward.

Reason for the Voluntary Recall

BVI has received feedback from a singular customer that one lot of Part Number 373807, Conventional Crescent Knife 2.5mm, 55 degrees bevel-up contains a bevel down blade. BVI determined the following lot is affected: 6054027.


Risk to Health

Inadvertently, using a bevel down blade instead of a bevel-up blade causes the surgeon to make an unintended incision architecture. A careful, observant surgeon is likely to notice the incorrect blade orientation under the microscope prior to use. However, when unnoticed, the unintended incision architecture potentially leads to an incision leakage. When incision leakage goes unnoticed, a watertight wound closure may not be achieved and thereby increasing the risk for anterior chamber fluid egress or ocular surface fluid ingress. Health effects include infection, iris prolapse, and intraocular pressure (IOP) fluctuations

Actions Required by You

Our records show you received one or more affected product. You can recognize the affected product by determining whether the lot number printed on the device label is one of the affected lots.

- Immediately examine your inventory and determine if the blades on the knives are bevel-up as intended or bevel down. Only destroy the knives in your inventory that have the incorrect bevel orientation (bevel down). If you have further distributed this product, please notify your customers by initiating a sub-recall. Consider all potential users of this product in your user supply chain. You are encouraged to use a copy of this recall notification letter when contacting your customers.
