With this Field Safety Notice we would like to inform you about a field action initiated by HOYA Corporation, PENTAX Tokyo Office relating to the following PENTAX brand suction valves:

	OF-B136 (red) Suction valve for FB-V, -X, EB-30, VNL-30 endoscopes (order code 82673)
	OF-B140 (red) Suction valve for FB-P, -BS endoscopes (order code 82688)
	OF-B163 (blue) Irrigation control valve for ECY-1570(K) endoscopes (order code 86488)
Land Market And Andrews Andrew	OF-B179 (red) Suction valve for VNL-70(K), EB-70(K) endoscopes (order code 86805)

According to our records you have received a number of the endoscopes affected. Please refer to the reply form stating all details of the endoscopes and valves in question.

Description of the problem:

PENTAX Europe GmbH was informed that a certain production lot of suction valves could possibly be subject to impaired functioning during endoscopy. This problem may cause the valve to get stuck in the valve cylinder or the rubber cap to become detached from the valve shaft. As a consequence, this may result in continuous suction.

Measures to be taken:

In case the valve gets stuck in the valve cylinder, we strongly recommend to interrupt or to completely turn off suction.

Furthermore, we would like to ask for your assistance to ensure that all valves concerned may be quickly identified and be replaced by PENTAX Europe GmbH. To this end, we are kindly asking you to complete the attached reply form and fax it as soon as possible to the fax number indicated.

We are aware that valves and endoscopes are not necessarily kept as a unit in daily practice. However, as there is no identification method available at the moment, we have decided to replace <u>all</u> "old" valves with new ones at no charge. Therefore, please return the valves withdrawn from your endoscopy section to PENTAX Europe GmbH with no delay in order to prevent any mix-up.

It is important for us to advise you that this action taken is a voluntary and preventative measure and that to date no incident related to this problem has been reported to us by users of our endoscopes.

Please ensure that all users of the above mentioned products in your organisation and all other individuals to be informed will receive this field safety notice. In case you have made these products available to third parties please forward a copy of this information to them or kindly provide us with the new contact data.

This information should at least be kept as long as the field measure has not been completed.

Please note that PENTAX Europe GmbH has notified the Competent Authority about this Field Safety Notice.
