The purpose of this notification is to advise you that Stryker Endoscopy is conducting a voluntary recall of Safelight Fiber Optic Cable Clear, 5MM X 10FT 305M (0233050100) and Safelight Fiber Optic Cable Gray, 5MM X 10F 3.05M. Please note that multiple lot numbers are affected by this issue.

## **Product description**

The cable features Electronic Scope-Sensing Technology (ESST), which detects when the cable is disconnected from the scope adapter, and it automatically powers off a compatible Stryker light source to prevent burns and fires. It is available in two models: 0233050100 (clear cable) and 0233050200 (gray cable). The cables are compatible with all Stryker light sources and requires a SafeLight scope adapter to connect to different brands of endoscopes.

The SafeLight<sup>™</sup> Fiber Optic Cable is intended to transmit light from a light source to an endoscope during endoscopic procedures.

## **Product issue**

During the investigation of a customer complaint it was determined that multiple lots of cables were not assembled with enough epoxy on the proximal end, creating light output issues.

### **Potential risks**

There is potential for user dissatisfaction and patient harm, as this could cause a clinical delay while replacing the light cable or result in a procedure being converted to open. To date there have been 16 reported adverse events.
