Recall - Market removal of Disposable EMR KIT and Distal Attachments

Dear Health Care Practitioner,

Olympus has become aware of an issue that requires your attention. This letter pertains to the DISPOSABLE DISTAL ATTACHMENT included in DISPOSABLE EMR KIT and Distal Attachment referenced above. The DISPOSABLE DISTAL ATTACHMENT has been designed to be attached to the distal end of the endoscope. It is to be used in combination with electrosurgical snares for endoscopic mucosal resection within the gastrointestinal tract. The distal attachment is also suitable for use in maintaining a suitable depth in the endoscopic field of view. The Distal Attachment has been designed to be attached to the Distal End of an Olympus endoscope to facilitate endoscopic therapy.

The products referenced above contain di-2-ethylhexyl phthalate (DEHP). Olympus has previously announced on the labeling that the product contains DEHP. Since Olympus has confirmed that alternative products can be provided, Olympus has decided to ask our customers to cease using the subject products and to further remove them.

Risk to Health

In general, potential patient harms associated with the use of plastic products containing DEHP include: chemical exposure, hypersensitivity/allergic reaction, endocrine disruption, reproductive and developmental toxicity and carcinogenicity. Long term DEHP toxicity may occur if a distal attachment inadvertently becomes a retained foreign body with resultant leaching over time. Olympus has not received any reports of these harms occurring from the use of our products.



Action steps to be taken by the end user:

Olympus has determined based upon our distribution records that your facility is in possession of one or more affected devices with a Lot number shown in Attachment 1. Olympus requires you to take the following actions:

- Immediately assess any product you have to identify the product number with affected lot listed in this communication, cease use of product and quarantine any affected product. The image below depicts the area where the lot number is identified. The lot# is on the Carton box and Pack. Please refer to the Attachment 2 for the identification of the subject products.
- 2. Ensure all personnel are completely knowledgeable and thoroughly trained on the content of this FSN.
- 3. If you have further distributed this product, identify your customers, and forward them this Field Safety Notice. Please appropriately document your notification process and let us know the end-customer feedback accordingly.
- Indicate on the Reply Form that you have received and understood this Field Safety Notice by filling out and returning the completed enclosed Reply Form back to your local Olympus representative XX.XX.XXXX latest by XX.XX.XXXX.
- 5. Your local Olympus representative will contact you to arrange return and appropriate reimbursement. Olympus will issue a Return Material Authorization to return any affected product at no charge to you. Olympus will issue a credit to your facility for your affected product.

Olympus requests that you report complaints, including patient physical condition suspected to be affected by DEHP, to Olympus. Please report complaints to [local facility complaint reporting contact]. 





The Gauge provided in the standard set has seven Openings in it, each number is inscribed with an order of 1, 2, 3, 7, 4, 5, 6 which starts from the smallest to the largest in diameter. These numbers match the Gauge Numbers of the following Tables. Fit the Distal Attachment into the Gauge using the above mentioned order (smallest to largest). By passing the Joint of the Distal Attachment through the Gauge find the smallest and passable Gauge Number for the Distal Attachment. Then find the type of the Distal Attachment by confirming the shape of the distal part of the attachment.
