With this Field Safety Notice, Etac provides information on important issues in relation to a Field Correction of Relax. The Field Safety Notice is intended to ensure that all users and health facilities with influence of Relax users will receive important information on the background and execution of this Field Correction.

Affected medical devices:

Relax wall mounted shower seat

For article and serial numbers: see page two of this document.

Background:

Etac has received information from a few users of malfunctions with the Relax wall mounted shower seat. It is reported that the seat in some cases gets cracks and in one case has broken. Etac is unaware that cracked seats would have resulted in any harm or serious injuries. There is however a potential risk for harm and injury if the wall mounted shower seat would break while used.

Field correction:

To prevent a potential situation of wall mounted shower seat crack or break, Etac is voluntarily issuing this Field Correction of all potentially affected wall mounted shower seats.

All Relax in the table on page two are within the scope of this field correction. The Relax wall mounted shower seat needs to be completely replaced to ensure a continuous long term safe use.

If you have a Relax within the affected serial number range, please contact your Etac representative to arrange for the replacement.

The activities will be carried out as soon as possible and is planned to be finished by latest December 31 2015.

There are no reasons for an immediate stop of using Relax, however as an intermediate precautionary action awaiting the replacement, you are requested to be observant and inspect the Relax wall mounted shower seat to see if there are visible signs of a crack.

Etac apologizes for any inconvenience, and asks user facilities that this notice is passed on to all those who need to be aware within your organization, or to any organization where the potentially affected devices have been transferred.
