Your site will be contacted by Siemens service to schedule the application of a patch or upgrade within the same MOSAIQ version that resolves this issue. This will happen once the resolution has been provided by Elekta.

MOSAIO v1.60V1 to v2.30.01: Customizing or Changing Numeric Regional Settings May Result in Mistreatment

IMPAC Medical Systems, Inc. has discovered an issue that may cause MOSAIQ to fail to recognize the designated decimal separator as valid, resulting in misinterpretation and/or incorrect display of fractional numeric data, or to correctly interpret date values under very particular conditions.

Versions 1.60V1 to 2.20.03

The cause of the issue is a defect in MOSAIQ's design to support Microsoft Operating System regional settings, specifically its ability to properly handle customized regional settings. Customized regional settings is defined as any modification to the standard, predefined Microsoft delivered regional settings. This customization can take place in one of three ways:

- Manually selecting the Customize button to modify the regional settings on a given workstation
- Pushing out a Windows group policy object with customized regional settings
- Using the MOSAIO feature Force all Workstations to use these Numeric Symbols

Versions 2.20.04 to 2.30.01

If Regional Settings are switched while MOSAIQ is running, there is also a potential for misinterpretation and/or incorrect display of fractional numeric data and date values.

Clinical Impact

There is a potential for mistreatment resulting in serious adverse health consequences if systemic misinterpretation of fractional numeric data is undetected by the user; however, the probability of such a critical mistreatment is remote, if users heed all treatment delivery warning messages and verify treatment parameters prior to overriding any such warnings. The mistreatment would result from MOSAIQ ignoring the decimal symbol for fractional numeric values (integers are not affected), and thus errantly converting a fractional value to an integer value, and refactoring the value by ten (10) or more. Incorrect meterset (Monitor Units or time) and/or incorrect geometric positions could be used for treatment. In the case of meterset (MU and time), the likelihood of the user being able to use the incorrect values for treatment without having been warned of a fractional dose mismatch is very remote (this likelihood is dependent on the distribution of field dose contribution). For geometric parameters, MOSAIQ would not allow treatment when values are out of range for the given treatment machine.

Hazard: Meterset = Monitor Units (MU)

If there is a zero to the right of the decimal, the MU will not be affected and will retain its integrity, e.g. 55,0 remains as 55,0. There is no factoring error. If there is a non-zero numeric character to the right of the decimal with resolution *deci*, the MU will be saved with a factoring error of 10. Integers are not affected.

Hazard: Meterset = Seconds or Minutes

If there is a non-zero numeric character to the right of the decimal with resolution *centi*, the time will be saved with a factoring error of 100. If there is non-zero numeric character to the right of the decimal with resolution *mili*, the time will be saved with a factoring error of 1000. Integers are not affected.

For Cobalt treatments that are manual recording only, the user could be misled by a time that has been errantly factored, but a resultant mistreatment would require the user to manually set that time on the machine.

Hazard: Geometric Parameters

Geometric parameters used for treatment could be affected by the misinterpretation of the decimal symbol. Gantry and collimator angle could be set incorrectly (e.g. 15,5 degrees can be misinterpreted as 155 degrees), and jaw and MLC positions could be set incorrectly (e.g. 1,5cm could be set to 15 cm).



Interim Mitigations

Perform the following steps in order:

- 1. Go to File | System Utilities | Department Setup | International tab, and uncheck or leave unchecked the Force all Workstations to use these Numeric Symbols feature. [Note: This setting applies to the entire database, so it only needs to be unchecked once to apply the change across all Departments in the same database.]
- Review the Microsoft Operating System regional settings on all MOSAIQ workstations that are set for English (United States). Verify that the decimal symbol is a dot ('.'), if you want to retain the English (United States) setting, or change the language/locale to something other than English (United States) if desired.



Elekta strongly warns you that Regional Settings must <u>never</u> be switched while MOSAIQ is running. Always close MOSAIQ prior to modifying Regional Settings.

Final Resolution

Product resolutions for this issue are being developed and will be available soon. MOSAIQ will continue to allow users to use customized regional settings, but will disallow non-standard decimal or digit grouping symbols. The *Force all Workstations to use these Numeric Symbols* feature will be removed. Additionally, MOSAIQ will detect when changes are made to Regional Settings while it is operating and display a warning to users.

Your site shall be contacted by Elekta Support to schedule the application of a patch or an upgrade within the same MOSAIQ version that resolves this issue. The patch/upgrade is mandatory. This patch/upgrade can be quickly applied and does \underline{not} entail an upgrade to a new version of MOSAIQ, new hardware, or network modifications.
